## Waiver of Liability

**X**\_\_\_\_\_ For and in consideration of enrollment in the International Shinkendo Federation, Aikibujutsu Tanren Kenkyukai (aka: Aiki Buken), and/or the Kokusai Toyama Ryu Renmei (referred to collectively as ISF/ AB/ KTRR) to obtain instruction and otherwise participate in the programs and seminars, the undersigned expressly agrees as follows:

**X**\_\_\_\_\_ That the ISF/ AB/ KTRR teaches Shinkendo (Japanese swordsmanship), Aikido/Aikibujutsu (Japanese self defense), and Toyama ryu (Japanese swordsmanship) respectively. That while on the premises of an ISF/ AB/ KTRR training hall – whether on a College/University campus, branch training hall, World Headquarters (Honbu) or any other location selected for the purpose of practice or demonstration, the undersigned hereby releases and agrees to hold harmless the ISF/ AB/ KTRR, as well as its instructors and assistants, from any claims for damages or losses of any kind. Such damages and/or losses could include, but not be limited to claims for personal injury, negligence occurring in, or arising out of training (including but not limited to broken swords, pieces of cut objects and other faults which may include loss of life or limb), property damages, resultant from use of a training location or participation in classes/ demonstrations.

**X**\_\_\_\_\_ Further, the undersigned understands and agrees that the ISF/ AB/ KTRR teaches swordsmanship and various methods of self defense, and that the student's participation in any of these, as with any martial art, will involve **inherent risks** in the practice and/or performance of such study. The undersigned, in the face of such knowledge of the risks, hereby expressly assumes such risks and agrees to waive any rights to any claims, damages or loss, and to hold harmless the ISF/ AB/ KTRR and its instructors and assistants, and/or any of its authorized agents from liability in regard to the aforementioned personal injury and/or property damages that may result from the use of a training facility/demonstration location and course/school participation.

**X**\_\_\_\_\_ The undersigned further agrees to waive any rights to any damages or losses, and hold harmless the ISF/ AB/ KTRR, its instructors and assistants, and/or any of its authorized agents from any claims that may result from the conduct of any of the other students or participants in the aforementioned programs, in regard to but not limited to any personal injuries, torts, or crimes of any type or kind – whether as a result of the use of a facility or equipment or outside the training facility through anything that may have been learned or demonstrated as part of a program of the ISF/ AB/ KTRR.
